PERMISSION SLIP

BSA Troop 68 is planning an outing to SHACKLEFORD BANKS, NC on MAY 16th – 18th, 2008. The Troop will leave from the Jamestown Presbyterian Church at 3:30 PM FRIDAY sharp and will return to the church at approximately 6:00 PM SUNDAY. The adult leaders in charge are MRS. SUSAN GRUNENWALD and MR. TOM GORE. Special instructions or equipment for this outing follow: THIS IS A DUAL CAMPOUT. THE DEADLINE FOR SIGN-UP IS MONDAY, MAY 12th, 2007 at 7:30 p.m.

- **The Troop** as a whole will camp Friday night on the mainland at Fishers Landing in the Croatan State Park just outside of Moorehead City. Base Campers will also camp at Fishers Landing Saturday night. Backpackers will camp Saturday on Shackleford Banks which is part of the Cape Lookout State park. Camping on Shackleford is primitive.
 - To be able to swim the scout will need to have been certified as a swimmer.
 - Troop will provide Saturday breakfast & lunch.
 - As usual bring a bag supper for Friday night & money for lunch on the way home on Sunday.
- **Base campers** will tour Shackleford Banks with the backpackers but will return to Fishers Landing Saturday evening. Saturday evening & Sunday morning will provide a good opportunity to work on skills and achievements. Bring daypack to carry a few water bottles onto Shackleford, (troop will supply water Saturday morning). Other essentials are bug repellent, sun screen, hat, raingear, swim wear and scout books. Optional: fishing gear.
- **Backpackers** must be 1st class or above. Backpackers will be hiking in over a mile on Shackleford Banks before setting up camp. Bring own food & supplies for Saturday Dinner & Sunday Breakfast. Also bring plenty of water. (see *Island Camping Requirements for details*)

Base campers cost is \$43.00 per scout for food, ferry fee and vehicle transportation. Backpackers cost is \$37.00 per scout for 2 troop meals, ferry fee and vehicle transportation. In the event of an emergency, the Troop can be reached through CELL 336-707-1928 (Susan) or 336-362-5725 (Tom) IF SERVICE IS AVAILABLE.
